



REQUIREMENTS FOR THE IMPORTATION OF SHEEP AND GOATS INTO MALAYSIA

- I. **Type of animal** : **Sheep and Goats**
- II. **Purpose** : **Slaughter**
- III. **Country of export** : **Australia**
- IV. **Requirements for Importation** :

1. Import Permit

The consignment animals shall be accompanied by a valid import permit issued by Malaysian Quarantine and Inspection Services Department (MAQIS) permitting the importation of such animals into the State(s) of Malaysia.

2. Description of Animal

The consignment of animals shall be accompanied by a certificate containing a full description or identification of the animals.

3. Identification of Animal

The animal shall be tagged with an ear tag for identification and traceability.

4. Veterinary Certification

The consignment of animals shall be accompanied by a Veterinary Health Certificate issued by a competent Veterinary Authority of Australia within 7 days of export, certifying that ;

- 4.1. The animals were clinically healthy and free from any infectious or contagious disease at the time of export and that part of the country or state of origin has been free from rinderpest, foot and mouth disease and contagious caprine pleuropneumonia for the past twelve (12) months prior to export.
- 4.2. The animals originated from an establishment or farm, where no case of Hendra virus infection has occurred during the last six (6) months prior to export.
- 4.3. The animals were dewormed and treated free from all internal and external parasites within seven (7) days prior to export.

5. Transportation and Landing Place

- 5.1. The consignment of animals shall be carried by ship or aircraft direct to the prescribed landing place or any other port or airport in Malaysia.
- 5.2. Only ruminant species and other animal species (camel, alpaca, Llama) that meet Malaysia import requirements shall be carried on the ship/aircraft during transportation from Australia. The animals must be loaded in a separate compartment as to avoid transmission of any disease which might occur during transportation.
- 5.3. No fodder or animal feeds should be taken on board the ship or aircraft at any intermediate port or airport, except the one that originated from Australia.

6. Other Conditions

Officers of the Department of Veterinary Services Malaysia (DVS) shall inspect the farm/s of origin of the animals in Australia as and when necessary.

7. Slaughter of Animal

- 8.1. All animals meant for slaughter shall be slaughtered in approved abattoirs as determined by DVS.
- 8.2. Animals that are not slaughtered immediately shall be held in an approved holding yard/farm.
- 8.3. Release of animals from the approved holding yard/farm for slaughter or sale shall be subject to movement regulations and slaughter procedures provide by DVS.
- 8.4. The importer shall maintain proper records of slaughter or sale of animals at the holding yard or farm, for inspection by DVS.

8. Suspension of Import

The Director General of Veterinary Services Malaysia or State Veterinary Director may at any time when deem necessary to suspend importations from Australia either temporarily or permanently in the event of disease outbreaks or suspected disease outbreaks in Australia or in case of importation in contravention of the above regulations.

9. Right to Amend Import Regulations

The Director General of Veterinary Services Malaysia shall amend the above regulations as he may deem necessary.
