UTM hasil makanan ternakan guna daun moringa

‘Murah berbanding palet komersial’

JOHOR BAHRU – Seorang pensyarah dari Universiti Teknologi Malaysia (UTM), di sini menghasilkan makanan ternakan alternatif yang menjimatkan sehingga 70 peratus berbanding makanan ternakan sedia ada.

Pensyarah Kanan di Jabatan Biosains, Fakulti Sains UTM, Dr. Mira Panadi berkata, makanan ternakan bernama ‘MoringaPro Pellet’ itu dihasilkan daripada Moringa Oleifera atau lebih dikenali sebagai daun moringa dan juga daun kelor.

“Produk itu merupakan satu inovasi yang mampu mengubah landskap industri ternakan den-

gan kos lebih jimat dan mampan.

“MoringaPro Pellet dihasilkan daripada daun moringa yang dijadikan sebagai sumber protein utama dan diperkaya dengan vitamin A, C, E, serta mineral penting seperti kalsium, zat besi, dan kalium.

“Formulasi inovatif ini menyokong kesihatan ternakan dengan hasil yang lebih baik berbanding makanan konvensional. Ia bukan sahaja kaya dengan nutrien, malah bentuk palet juga dapat mengurangkan kesan anti nutrien sekali gus menjadikannya lebih berkesan dan selamat,” katanya ketika ditemui di sini baru-baru ini.

Katanya, MoringaPro Pellet juga menawarkan penjimatkan

kos bagi pembelian makanan ternakan sehingga 70 peratus dengan kos bahan mentah dianggarkan berharga kira-kira 80 hingga 90 sen sekilogram.

“Nilai itu jauh lebih rendah berbanding harga palet komersial ketika ini yang boleh mencerek RM3.50 hingga RM4.10 sekilogram.

“MoringaPro Pellet menggunakan bahan-bahan tempatan yang mesra alam, palet ini juga mengurangkan jejak karbon selain menyokong ekonomi petani-petani tempatan,” ujarnya.

Jelasnya, produk itu telah dipatenkan melalui Perbadanan Harta Intelek Malaysia (MyIPO) bagi melindungi formulasi dan proses penghasilannya bulan lalu.

Over 100 animal lovers gather to demand justice for strays

KUALA LUMPUR: The recent killing of stray dog Kopi (pic) in Terengganu was again highlighted in Parliament after more than 100 animal lovers from 32 groups convened at the gates of the building to demand justice and rights for stray animals.

Braving the morning rain, the group arrived by 10.30am yesterday, hoisting placards and banners calling for immediate legal reforms in the handling of stray animals.

The news of Kopi's death in September, which had sparked an outcry on social media, already led to a fierce exchange between MPs in the August House two weeks ago.

Last month, Besut District Council said the shooting of Kopi was carried out in accordance with the laws, adding that its team was prevented from retrieving the dog's remains by certain individuals.



The council's statement was issued in response to a Facebook post shared by Stray Animal Feeders of Malaysia (SAFM) on Oct 12.

During yesterday's gathering, which was organised by Global Human Rights Federation (GHRF) and led by SAFM, the group chant-

ed "justice for Kopi" and "justice for all animals" outside the gates with about 40 police officers present to manage nearby traffic and the crowd.

The group was later met by a delegation of MPs led by Deputy Minister in the Prime Minister's Department (Law and Institutional Reforms) M. Kulasegaran and former prime minister Datuk Seri Ismail Sabri Yaakob, who received the memorandum from the members.

GHRF president S. Sashi Kumar told reporters that the memorandum was to seek amendments to the Animal Welfare Act 2015 and advocate for humane and sustainable practices in stray animal management.

"We no longer want the protection of strays to be under the Department of Veterinary Services anymore. It has failed us tremendously," Sashi said.

The memorandum lists a num-

ber of key demands to the government, which include the setting up of a new independent animal welfare board to monitor, enforce and support humane practices in animal welfare nationwide.

Other demands include reforms to the Act to prohibit cruel treatment of strays and inhumane capture methods, mandate a national trap-neuter-return programme, and strict regulation of animal breeders.

The group also demanded that local animal pounds be transformed into no-kill facilities so rehabilitation and adoptions become the norm.

They dispersed peacefully at around 12.30pm.

Later in the Dewan Rakyat, Kampar MP Chong Zhemin and Segamat MP R. Yuneswaran, both from Pakatan Harapan, raised the matter during Housing and Local Government Minister Nga Kor Ming's winding-up speech on the

Supply Bill 2025.

"Can you give us a guarantee on this issue, whether we will revise local town council laws so that animals are not cruelly killed under the Madani government?" asked Yuneswaran.

Nga said investigations and disciplinary action will be taken against any local authority officers who do not abide by the Act.

He also urged individuals not to have pets if they are not responsible pet owners.

During his winding-up speech, Nga also said putting down strays is a last resort adopted by local councils.

Nga noted that the ministry presently uses methods such as capturing, claiming or handing over stray dogs or cats to NGOs for relocation.

"Euthanasia is only for animals that are diseased, frail, causing a nuisance, or posing a danger to the public," he said.

Saiznya yang jauh lebih kecil berbanding tupai biasa menjadikan mamalia ini sangat unik.

Tupai mini ini berukuran kira-kira tujuh hingga 10 sentimeter (cm) termasuk ekornya. Manakala saiz badannya seperti jari kelingking orang dewasa.

Wan Mohd Zamri Wan Ismail, 37, berkata, dia mula berjinak-jinak memelihara tupai mini, kira-kira lima tahun lalu.

Menurutnya, dia mengetahui kewujudan mamalia itu daripada rakan-rakan dan 'terpikat' dengan kecomelan haiwan berkenaan sebelum memutuskan untuk memeliharanya.

"Saya membeli baka tupai ini dari negara jiran kemudian membiakkannya dan kini berjumlah lebih 200 ekor.

"Antara keunikan tupai mini selain daripada saiz badan yang kecil ialah mudah dijaga kerana jarang menghidap penyakit yang boleh mengakibatkan kematian.



WAN Mohd Zamri peliharaan tupai mini kira-kira lima tahun lalu.

"Kos penjagaan juga rendah kerana hanya makan buah-buahan dalam kuantiti sedikit iaitu sehari sekali," katanya.

Dia yang menetap di Wakaf Bharu, Kelantan berkata, menariknya mamalia ini ialah tidak berbau busuk seperti sesetengah haiwan peliharaan lain.

"Kelebihan ini menjadikan tupai mini sesuai dipelihara dalam rumah dan tidak akan menjelaskan keselesaan penghuni.

"Selain itu, tupai mini mesra kanak-kanak kerana jinak dan tiada risiko mencederakan serta jangkitan penyakit," katanya.

"Lebih banyak bulu tupai mini warna putih maka ia dikategorikan sebagai jarang jumpa dan berkualiti tinggi," katanya.

PETALING JAYA:

Thirty-four animal welfare groups have submitted a memorandum to Parliament, demanding legislative reform for the protection of strays.

The initiative was organised by the Global Human Rights Federation and led by Persatuan Haiwan Terbiar Malaysia (SAFM) in collaboration with the Malaysian Animal Welfare Association.

SAFM president Kalaivanan Ravichandran told FMT the memorandum was received by deputy law and institutional reform minister M Kula Segaran and several others, including Bera MP and former prime minister Ismail Sabri Yaakob and Kampar MP Chong Zhemin.

"It is time to stop the inhumane treatment and ensure accountability in how stray animals are managed in our communities," Kalaivanan said.

The memorandum lists eight key demands, including for the government to set up a body under the Prime Minister's Department to monitor, enforce and support humane practices in animal welfare nationwide.

This body would oversee the local authorities' compliance with humane practices and address cases of animal cruelty.

The other demands include reforms to the Animal Welfare Act 2015 to prohibit cruel treatment of strays and harsh capture techniques, mandate a national trap-neuter-return programme, and strict regulation of animal breeders.

The groups also want animal pounds operated by local authorities to be transformed into no-kill facilities to ensure that rehabilitation and adoptions can take place.

The memorandum was initiated following the culling of a stray dog named Kopi in Terengganu.

Last month, 13 NGOs demanded action by the veterinary services department against municipal officers who kill stray dogs, after Kopi's case went viral on social media.

The NGOs claimed that municipal officers tasked with managing the stray population often resort to inhumane practices, including beating the dogs with iron rods and dragging them by the neck.

The department said it will review the memorandum it received from the 13 NGOs and that it will also provide updates on its investigation being carried out under the Animal Welfare Act.

He said currently, the ministry uses methods such as capturing, claiming and prioritising adoptions or handing over stray dogs or cats to non-governmental organisations (NGOs) for relocation.

"Disposal through the 'put to sleep' method is only carried out as a last resort in the management of stray animals. It is only for animals that are sick, elderly, or causing disturbances that pose a risk to public safety including rabies," he said during the ministry's winding-up session of the 2025 Budget.

On suggestions to implement the Trap, Neuter, Vaccinate, and Release (TNVR) method, he said, it has not yet been recognised as an international standard mechanism and poses significant financial and human resource implications for each local council if implemented.

He said that the Stray Dog Capture and Disposal Guidelines are used by all state authorities and local authorities to manage the issue of stray animals which are implemented alongside the Dog Licensing By-Laws (UUK) for enforcement by local councils within their respective administrative areas.

He assured that any local council that fails to comply with the guidelines to dispose of stray animals under the Animal Welfare Act would have to face investigation and disciplinary action.

"If the ministry receives complaints regarding any party that fails to comply with these guidelines, the ministry will investigate the matter and take further action, including disciplinary action.

"We have the Animal Welfare Act and clear guidelines. Any local authority that fails to comply will have to face investigation and disciplinary action. That is clear," he said.

He said the other method for managing stray dogs was the Trap, Neuter and Release (TNR) method, which has been implemented by the Penang Island City Council (MBPP) in collaboration with the International Aid for the Protection and Welfare of Animals (IAPWA) since 2019.

"The TNR method has resulted in the capture of 5,308 stray dogs by local authorities, which were then released back into public areas, but without receiving booster rabies vaccinations.

"Until now, this issue continues to cause disruptions in the community. We have to take a balanced approach to be fair. Among the issues are property damage, road accidents, faeces on roads or sidewalks, as well as dog bites, injuries and the risk of spreading rabies.

"If the TNVR method is adapted, the number of stray animals will not decrease but will continue to increase the risks to public order, safety and wellbeing," he said.

He added that the number of complaints related to stray dogs in 2023, specifically in Sarawak, was 2,712 complaints, with 15,831 dog bite cases and 109 rabies cases.

As of August 2024, he said, 1,027 complaints of stray dogs were received, with 12,529 dog bite cases and five rabies cases.

"The decline in these statistics is due to proactive actions by the local authorities in collaboration with the Veterinary Services Department, which conducted 2,386 stray animal capture and disposal operations throughout the year," he said.

Last month, there was public outrage after a stray dog named Kopi was shot by local council authorities in Terengganu, just two days after World Animal Day.

Kopi's killing was defended by Besut member of parliament Datuk Che Mohamad Zulkifly Jusoh, who reportedly said the action was part of efforts to address the growing problem of stray dogs.

However, Kampar member of parliament Chong Zhemin said under the Animal Welfare Act 2015, such actions were not permitted without following proper procedures.

The memorandum, titled "Justice for Kopis and All Stray Animals", demands immediate changes to the Animal Welfare Act 2015.

"We are here to demand an end to the killing and inhumane treatment of stray animals. Our animals deserve compassion, not cruelty," said SAFM president Kalaivanan Ravichandran.

He said Malaysia needed "strong laws and humane standard operating procedures to protect stray animals. No animal should suffer like Kopi did."

The memorandum urged the government to amend the Animal Welfare Act to explicitly prohibit cruel practices such as shooting, poisoning and harsh capture techniques and called for clear legal protection to ensure local authorities adopt humane standards in managing strays.

The memorandum also demanded for the establishment of an independent animal welfare board which would oversee local authorities' compliance with humane practices, enforce penalties for animal cruelty and address cases of mistreatment.

The memorandum called for stricter enforcement of penalties, such as substantial fines and imprisonment for offenders, along with regular audits of local authority practices and pound conditions to ensure humane treatment.

Other demands are a national trap-neuter-return programme, the transformation of pounds into no-kill facilities, and reserving euthanasia only for severe medical cases.

Additionally, it advocated banning inhumane capture methods and stricter regulation of animal breeders.

In October, heated exchanges in Parliament occurred over the [shooting of Kopi](#), with Besut member of parliament Datuk Che Mohamad Zulkifly Jusoh defending the council's actions.

KUALA LUMPUR: Over 100 animal lovers from 32 groups braved the morning downpour to gather at the gates of Parliament and demand justice and rights for strays.

At around 10.30am Tuesday (Nov 12), the group hoisted placards and banners calling for immediate legal reforms in the handling of stray animals.

This comes after a dog, lovingly named Kopi, was allegedly shot dead by a local council representative from the Terengganu Veterinary Services Department (DVS) last month.

Organised by the Global Human Rights Federation (GHRF) and led by Persatuan Haiwan Terbiar Malaysia (SAFM), the group chanted “justice for Kopi” and “justice for all animals” outside the gates as about 40 police officers were present for traffic and crowd control.

The group was later met by a delegation of MPs led by Deputy Minister in the Prime Minister’s Department (Law and Institutional Reform) M. Kulasegaran (PH-Ipoh Barat) and former prime minister Datuk Seri Ismail Sabri Yaakob (BN-Bera) who received the memorandum.

GHRF president S. Sashi Kumar told reporters the memorandum was to seek amendments to the Animal Welfare Act 2015 and advocate for humane and sustainable practices in stray animal management.

“We no longer want the protection of strays to be under DVS anymore. It has failed us,” Sashi said.

The memorandum lists several key demands which include the setting up of a new independent board to monitor, enforce and support humane practices in animal welfare.

The proposed animal welfare board would oversee local authorities’ compliance with humane practices and address cases of cruelty.

Other demands include reforms to the Act prohibiting cruel treatment of strays and inhumane capture methods, mandating a national trap-neuter-release programme, and strict regulation of animal breeders.

The group also demanded that local animal pounds be transformed into no-kill facilities so that rehabilitation and adoption become the norm.

The group dispersed peacefully at around 12.30pm after handing over the memorandum.

> Stricter ownership regulations and prioritising adoption:
Amend Section 24 (Duties of Owner or Licensee) to include a clause that mandates potential pet owners to explore adoption options as a priority. The clause could read, “No person shall obtain a pet through purchase if a suitable animal is available for adoption from registered animal shelters or rescues”.
