SHAH ALAM - Jabatan Perkhidmatan Veterinar (DVS) akan meneliti memorandum yang diterima daripada beberapa persatuan haiwan berhubung isu anjing ditembak mati semasa operasi penangkapan dan pelupusan anjing liar yang dijalankan oleh Majlis Daerah Besut pada 6 Oktober lepas.

keputusan dasar jabatan berkenaan.

DVS To Review 'Kopi' Shooting After Receiving Memorandum From Animal Groups

PUTRAJAYA, Oct 19 — The Department of Veterinary Services (DVS) is set to review a memorandum received yesterday from several animal associations concerning the shooting of a dog during an operation to capture and dispose strays by the Besut District Council (MDB) on Oct 6.

In a statement today, DVS informed that it would provide updates on the ongoing investigation under the Animal Welfare Act 2015 (Act 772), following its departmental policies.

“DVS headquarters confirms the receipt of a memorandum from several animal associations regarding this matter.

“The operation, which took place on Oct 6, 2024, was conducted in Kampung Raja, Paya Rawa, Pengkalan Nyireh, Air Tawar, Tanjung Demong, Gelam Mas and Jertih in the Besut district. It involved 25 personnel from MDB, the Besut District Veterinary Office and the Kota Putera state legislative office,” read the statement.

On Oct 13, MDB president Mohd Sukeri Ibrahim said the shooting of the stray dog named 'Kopi' was carried out according to established procedures. He denied allegations that the dog was abandoned by council staff after it was shot, as had gone viral on social media since early this month.

Recently, the My Forever Doggo (MFD) Facebook page shared a 52-second video showing Kopi succumbing to severe injuries. The dog was found by a local resident in a nearby residential area after gunshots were heard.

The video has drawn widespread attention and sparked debate among netizens, especially animal lovers who are demanding justice for the stray dog's death. — [MALAYMAIL](#)

In a statement on Saturday (Oct 19), DVS said it would provide updates on an ongoing investigation under the Animal Welfare Act when available.

"DVS headquarters confirms the receipt of a memorandum from several animal associations regarding this matter.

"The operation, which took place on Oct 6, 2024, was conducted in Kampung Raja, Paya Rawa, Pengkalan Nyireh, Air Tawar, Tanjung Demong, Gelam Mas and Jertih in the Besut district.

"It involved 25 MDB personnel, the Besut District Veterinary Office and the Kota Putera state legislative office," read the statement.

On Oct 13, MDB president Mohd Sukeri Ibrahim said the shooting of a stray dog named 'Kopi' was carried out according to established procedures.

Animal lover groups had recently questioned if MDB carried out the operation in accordance with the AWA as well as guidelines issued by the Housing and Local Government Ministry. –

PETALING JAYA: The veterinary services department says it will review the memorandum it received from 13 NGOs demanding action against municipal officers who kill stray dogs, following the culling of a stray dog named Kopi in Terengganu.

The department said it will also provide updates on its investigation into the incident being carried out under the Animal Welfare Act.

In a statement, it said the incident took place during an operation on Oct 6 at Kampung

Raja, Paya Rawa, Pengkalan Nyireh, Air Tawar, Tanjung Demong, Gelam Mas and Jertih in Terengganu's Besut district.

The operation involved 25 officers and staff from the Besut district council, the Besut district veterinary office and the office of the Kota Putera assemblyman.

The NGOs, led by the Global Human Rights Federation, claim that municipal officers tasked with managing the stray population often resort to inhumane practices,

including beating the dogs with iron rods and dragging them by the neck.

They said such actions cause either severe injuries to the dogs or lead to their death.

In the memorandum addressed to veterinary services director Dr Akma Nga Hamid, they called on the department to enforce the Animal Welfare Act and take action against officers violating the law.

Kopi went viral on social media in March for playing with a stray cat.

A coalition of animal rights groups has since said it would file a civil suit against the Besut district council for shooting Kopi. A police report was also lodged over Kopi's killing.-[FMT](#)

KUALA LUMPUR: The Veterinary Services Department will review a memorandum received from 13 animal rights groups and non-governmental organisations demanding actions against the Besut District Council over the killing of a stray dog.

The department, in a statement today, said it will also provide updates on the ongoing investigation into the incident that is being carried out under the Animal Welfare Act 2015.

"The department confirms to have received a memorandum from several animal associations over the operation.

"The operation on Oct 6 took place in Kampung Raja, Paya Rawa, Pengkalan Nyireh, Air Tawar, Tanjung Demong, Gelam Mas and Jertih in the Besut district," the statement said.

The department added that the operation involved 25 personnel from the district

council, the Besut District Veterinary Office and the Kota Putera state legislative office.

The district council recently drew criticism after a stray dog, named Kopi by the locals, was shot in an operation by the council early this month.

Social media account My Forever Doggo, in a post on Instagram, claimed that residents saw a local council representative in Terengganu shoot the dog.

The district council's chairman Sukeri Ibrahim, however, defended the shooting.

Sukeri said the operation was conducted in accordance with standard operating procedures established by the Housing and Local Government Ministry.

He said the council had between Jan to Sept this year, received 62 complaints from the public about stray dogs in the district.-
