KUALA LUMPUR, Aug 7 (Bernama) -- Modern livestock systems that focus on high biosecurity aspects are capable of controlling the spread of the African Swine Flu (ASF) effectively, Agriculture and Food Security Minister Datuk Seri Mohamad Sabu said today.

This was in line with the National Agro-food Policy 2.0 that emphasised the use of modern technology as part of the transformation of the national livestock sector.

"In the long run, ASF is

expected to be the major obstacle in boosting domestic production and affecting the national selfsufficiency rate (SSR) for pork.

"As such, transition to modern pig farming systems is an accurate strategic step to ensure the rise in SSR," he said during a special chambers session at the Dewan Rakyat today, in response to a question by Khoo Poay Tiong (PH-Kota Melaka) regarding the national development plan to ensure that the SSR can be achieved and the need to

strengthen research and development (R&D) efforts to curb the spread of ASF.

He stressed that his ministry, through the Department of Veterinary Services (DVS), has implemented R&D initiatives focused on detection and understanding the ASF virus, including conducting a thorough study on the ASF virus genes using Whole Genome Sequencing.

The technology would enable complete identification of information regarding the virus, including infection rates, genetic changes and help in identifying the cause of infections more effectively, he added.

Mohamad also revealed that there were 15 licensed abattoirs for pigs in Peninsular Malaysia, centred in Penang, Johor, Perak, Selangor and Pahang, based on official data of private operation licence holders.

He said the DVS would consider adding the number of pig abattoirs if applicants submitted complete applications and fulfilled industry needs.-**BERNAMA**

Malaysia Mulls Lifting Pork Import Ban From Thailand to Address Rising Retail Prices

KUALA LUMPUR: Malaysia is considering lifting its ban on pork imports from Thailand as part of efforts to stabilise retail prices which have been soaring in recent months, says Datuk Seri Mohamad Sabu.

The Agriculture and Food Security Minister said the Veterinary Services Department (DVS) had re-evaluated the risk analysis related to African Swine Fever (ASF) and was now considering allowing pork cuts from Thailand to be imported once again.

However, he said this would be subject to strict conditions, including full compliance with Malaysia's import requirements agreed upon with Thai veterinary authorities, as well as audits and recommendations from DVS before approval is granted.

"At present, ASF is categorised as endemic in Malaysia, with outbreaks continuing to emerge from time to time in certain areas," he said in a written parliamentary reply on

Wednesday (Aug 6).

Mohamad said the most recent outbreak was detected on July 9 in Kampung Selamat, Seberang Perai Utara, Penang, affecting three pig farms with a combined pig population of 2,799.

As of now, he said a total of 578 pigs have been culled and disposed of, while 124 deaths have been recorded. Culling operations at all three farms remain ongoing.

He said Penang DVS has enforced various measures to contain the outbreak, including restricting pig movement, disinfecting affected farms and destroying infected livestock.

Responding to Cha Kee Chin (PH-Rasah), who raised concerns about soaring pork prices and the government's preparedness to temporarily allow imports from neighbouring countries, the ministry acknowledged the situation but clarified that retail pork pricing falls under the purview of the Domestic Trade and Cost of Living

Ministry.

Nevertheless, Mohamad said his ministry had taken several steps to ensure pork supply remains sufficient across the country.

These include approving imports from several overseas abattoirs, evaluating new potential export countries such as Brazil and Thailand, and facilitating the transport of live pigs from Sarawak to Selangor for slaughter to meet the growing demand for fresh pork in Peninsular Malaysia.

He added that it would continue monitoring the situation closely while upholding stringent health and safety standards in any decision involving pork importation.-[THESTAR](#)

KUALA LUMPUR: The Department of Veterinary Services (DVS) is considering lifting the ban on pork imports from Thailand as part of efforts to address the rising cost of pork in the market, following recent outbreaks of African Swine Fever (ASF).

Agriculture and Food Security Minister Datuk Seri Mohamad Sabu said the ministry had reassessed the risk analysis related to ASF and was reviewing the possibility of reallowing pork imports from Thailand, which

were suspended in 2019.

Apart from Thailand, the other exporting countries were China, Poland, Belgium, Vietnam and Cambodia.

"The consideration is subject to full compliance with Malaysia's veterinary import requirements, including audit inspections and formal approval by DVS," he said in a written reply to Cha Kee Chin (PH-Rasah) in the Dewan Rakyat.

Mohamad said the decision would also take into account

the current demand and the need to ensure adequate supply.

He said the ministry had taken several steps to strengthen pork supply, including approving 130 abattoirs from nine countries to export pork to Malaysia, and facilitating the export of live pigs from Sarawak to Selangor for slaughter purposes.

"These measures are necessary to support the local supply chain and stabilise prices, especially in Peninsular Malaysia," he added.

Mohamad also said DVS was in the process of evaluating Brazil as a potential new source country for pork imports.

On the ASF situation, he confirmed that the disease remains endemic in Malaysia.


The latest outbreak was reported on July 9 in Kampung Selamat, Seberang Perai Utara, Penang, affecting three pig farms with a combined total of 2,799 pigs.

"As of now, 578 pigs have been culled and disposed of, with 124 deaths reported. Eradication efforts at the affected farms are still ongoing," he said.

The Penang Veterinary Services Department has implemented several control measures at the outbreak sites, including restrictions on livestock movement, culling of infected animals, and disinfection of the premises.-[NEWSTRAITSTIMES](#)

Man in Viral Video Beating Pet Dog 'Lucky' Fined Rm30,000

KUALA LUMPUR, Aug 7 (Bernama) -- A man who went viral for beating his pet dog, 'Lucky', with a wooden stick and rubber hose was fined RM30,000 by the Ampang Sessions Court today after he pleaded guilty to the offence.

Judge Norshila Kamarudin handed down the sentence to airconditioning technician Kiew Mun Kiat, 43, and ordered him to serve six months' jail if he failed to pay the fine. He paid the fine.

The court also ordered the

dog to be forfeited to the government for adoption through the Selangor Veterinary Services Department by qualified and interested members of the public.

Kiew was charged with brutally assaulting a male German Shepherd using a wooden stick and rubber hose multiple times at his home in Pandan Indah at 5.29 pm on July 31.

The charge, framed under Section 29(1)(a) of the Animal Welfare Act 2015, provides for

a fine of between RM20,000 and RM100,000, or imprisonment of up to three years, or both, upon conviction.

According to the facts of the case, between 5.29 pm and 5.41 pm on July 31, a resident recorded footage of Kiew hitting the dog using a mobile phone. The video was later uploaded and went viral across several social media platforms.

A joint inspection by the Selangor Veterinary Services Department and Ampang Jaya police, following public complaints, led to the discovery of a tied-up male dog named 'Lucky', along with a wooden stick and rubber hose in the house compound.

A physical examination conducted on the dog on Aug 1 revealed a wound on the front of its left leg, along with localised hair loss (alopecia) and skin redness (erythema).

Earlier, Selangor Veterinary Services Department prosecuting officer Mohd Sharif Sabran urged the court to impose a heavy sentence, citing public interest and the seriousness of the animal cruelty offence.

"In this case, OKS (Kiew) repeatedly beat his dog,

resulting in injuries that could cause trauma to the animal. The prosecution is also requesting that the dog be forfeited to the government for adoption by eligible and interested members of the public through the Selangor Veterinary Services Department," he said.

Kiew, who was unrepresented, appealed for a lighter sentence on the grounds that he was supporting his family, and that he beat the dog to teach it a lesson after it bit his hand.-[BERNAMA](#)

AMPANG – Tindakan seorang lelaki yang memukul anjing jantan peliharaannya yang digelar 'Lucky' secara bertubi-tubi menggunakan rotan kayu dan getah paip membawa padah apabila dia didenda RM30,000 oleh Mahkamah Sesyen di sini hari ini.

Hakim Norshila Kamarudin menjatuhkan hukuman denda itu selepas Kiew Mun Kiat, 43, selaku orang kena saman (OKS) mengaku salah atas pertuduhan yang disabitkan ke atasnya.

Sekiranya OKS gagal

membayar jumlah denda itu, dia boleh dipenjara selama enam bulan dan OKS membayar denda berkenaan.

Mahkamah juga turut memerintahkan haiwan itu dilucut hak kepada kerajaan untuk tujuan pengangkatan kepada orang awam yang layak dan berminat.

Mengikut pertuduhan, OKS yang bekerja sebagai penyelenggara pendingin hawa itu didakwa dengan kejamnya telah memukul anjing jantan baka Jerman Sherpherd dengan menggunakan rotan kayu

dan getah paip berwarna kuning secara bertubi-tubi.

Kesalahan itu didakwa dilakukan rumahnya di Jalan Pandan Indah di sini antara pukul 5.29 petang hingga 5.41 petang pada 31 Julai lalu (2025) yang didakwa mengikut Seksyen 29(1)(a) Akta Kebajikan Haiwan 2015 dan boleh dihukum dibawah seksyen yang sama.

Hukuman bagi seksyen itu memperuntukkan denda tidak kurang RM20,000 dan tidak lebih RM100,000 atau penjara tidak lebih tiga tahun atau kedua-duanya.

Terdahulu OKS yang tidak diwakili peguam memohon dikenakan hukuman ringan dengan alasan menanggung keluarga selain memaklumkan tindakannya memukul anjing itu adalah untuk mengajar.

“Saya mahu ajar dia sebab dia gigit tangan saya, mohon hukuman rendah,” katanya.

Bagaimanapun Pegawai Pendakwaan Perkhidmatan Veterinar (DVS) Selangor, Mohd. Sharif Sabran memohon mahkamah mengenakan hukuman berat dengan mengutamakan kepentingan awam.

“Pihak pendakwaan mohon mahkamah mengambil kira keseriusan kes berkaitan

penganiayaan haiwan apabila dalam kes ini OKS memukul anjingnya bertubi-tubi dengan kesan kecederaan yang boleh mendatangkan trauma kepada haiwan tersebut.

“Pihak pendakwaan juga memohon supaya anjing itu dilucut hak kepada kerajaan untuk tujuan pengangkatan kepada orang awam yang layak dan berminat melalui Jabatan Perkhidmatan Veterinar Selangor,” katanya.

Mun Kiat didakwa dengan kejam memukul seekor anjing jantan baka Jerman Sherpherd dengan menggunakan sebatang

rotan kayu dan satu getah paip berwarna kuning secara bertubi-tubi, di rumahnya di Pandan Indah, pada 5.29 petang, 31 Julai lepas.

Pertuduhan dikemukakan mengikut Seksyen 29(1)(a) Akta Kebajikan Haiwan 2015 (Akta 772) dan boleh dihukum di bawah seksyen sama, yang memperuntukkan hukuman denda tidak kurang RM20,000 dan maksimum RM100,000 atau penjara tidak lebih tiga tahun atau kedua-duanya.

Berdasarkan fakta kes, antara jam 5.29 petang hingga 5.41 petang, pada tarikh sama (31 Julai), perbuatan Kiew memukul anjing itu dirakam penduduk sekitar rumahnya menggunakan telefon bimbit sebelum dimuat naik dan tular di beberapa rangkaian media sosial.

Bertindak atas maklumat dan aduan awam, sepasukan Pegawai Kebajikan Haiwan daripada Jabatan Perkhidmatan Veterinar Selangor dan sepasukan pegawai serta anggota polis daripada Ibu Pejabat Polis Daerah Ampang Jaya menjalankan pemeriksaan di rumah OKS dan mendapat terdapat seekor anjing jantan bernama 'Lucky' dalam keadaan diikat selain menjumpai satu batang rotan dan satu getah paip di

kawasan perkarangan rumah terbabit.
