

**REGULATIONS FOR THE IMPORTATION OF DOGS AND CATS
FROM THE SCHEDULED COUNTRIES INTO MALAYSIA**

- A. Animal : Dogs and Cats
- B. Country of Export : United Kingdom, Eire, Northern Ireland, New Zealand, Japan, Sweden, Brunei and Singapore.
- C. Purpose : Any Purpose
- D. Regulation for importation ;

1. Import Permit

- 1.1. The consignment of animals shall be accompanied by a valid import permit issued by Malaysian Quarantine and Inspection Services Department (MAQIS) concerned permitting the importation of such animals into Malaysia.
- 1.2. For dogs, the approval to get the import permit is also subjected to the breed of the dogs (refer to clause no 6: List of Banned/Restricted Breeds of Dogs and clause no 7: Conditions for the Approval of Importation of Restricted Breeds of Dogs)

2. Description of Animal

- 2.1. The consignment of animal shall be accompanied by a pet passport or certificate containing a full description or identification of the animals.
- 2.2. The animal shall be identified using an ISO (Std 11784 & 11785) compliant microchip.

3. Veterinary Certification

The consignment of animals shall be accompanied by a Veterinary Health Certificate issued by a competent veterinary officer of the Government Veterinary Authority of exporting country certifying that :

- 3.1. No case of rabies had been reported to have occurred in that country during the six (6) months preceding the date of the certificate.
- 3.2. The animal had not been imported into the country during the six (6) months preceding the date of the certificate.
- 3.3. The animal has been vaccinated against rabies using an approved anti-rabies vaccine, prior to export.
- 3.4. The animals shall be vaccinated within twelve (12) months prior to export with other core vaccine as recommended by license veterinarian.
- 3.5. The vaccination history status, treatment given and health status of the animal is up to date.
- 3.6. The animal has been examined and found to be healthy and free from any clinical sign of infectious or contagious disease , within seven (7) days prior to export and certification, and showed no any clinical signs on the day of shipment.

4. Transportation and Landing Place

The animals shall be carried by aircraft direct from the above countries to the prescribed landing place or any other airport in Malaysia.

5. List of Banned / Restricted Breed of Dogs

5.1. Restricted Breed of Dogs

- 5.1.1. Bull Mastiff
- 5.1.2. Bull Terrier

5.2. Banned Breed of Dogs

- 5.2.1. Akita
- 5.2.2. American Bulldog
- 5.2.3. Dogo Argentino
- 5.2.4. Fila Brasileiro
- 5.2.5. Japanese Tosa
- 5.2.6. Neapolitan Mastiff
- 5.2.7. Pit Bull Terrier / Pit Bull (also known as American Pit Bull, American Pit Bull Terrier, American Staffordshire Terrier and Staffordshire Bull Terrier)

6. Condition for the Approval of Importation of Restricted Breed of Dogs

An approval to import restricted breeds of dogs shall be obtained in writing from the Director General of Malaysian Quarantine and Inspection Services Department (MAQIS) subject to the following conditions, prior to application of an import permit;

- 6.1. Dogs shall not be less than 3 months of age at the time of import.
- 6.2. Dogs shall have a pedigree certificate issued by an approved organisation in the country of export (name and address of the organisation shall be specified).
- 6.3. Dogs shall be identified using an ISO (Std 11784 & 11785) compliant microchip and the identification codes clearly recorded in the pedigree certificate.
- 6.4. Name and address of the importer who shall be responsible for the care and handling of the dog shall be clearly stated in the application for approval.
- 6.5. The premise or residence of the dog shall be inspected by the Director to verify facilities regarding kennel, size of the compound, safety and control of the dog
- 6.6. The importer shall provide a written declaration that the dog ;
 - 6.6.1. is a personal pet and not intended for sale (Importation of controlled breeds of dogs is allowed as a personal pet of the importer or for security purpose only)
 - 6.6.2. shall be kept secured within the compound at all times
 - 6.6.3. shall be kept on a leash and muzzled at all times in public area
 - 6.6.4. shall be under the control of a trained and skilled handler at all times (for Security Dogs)

7. Suspension of Import

The Director General of Veterinary Services or State Veterinary Director may at any time when deem necessary to suspend importation from any countries either temporary or permanently in the

event of disease outbreak or suspected disease outbreak in the countries or in the case of importation in contravention of the above regulation.

8. Right to amend Import Regulations

The Director General of Veterinary Services shall amend the above regulation at any time as he may deem necessary.

United Kingdom, Eire, Northern Ireland, New Zealand, Japan, Sweden, Brunei, Singapore, Greece, Luxembourg, Czech Republic, Malta, Slovenia, Estonia, Bahrain, Austria, Belgium, Germany, Portugal, Montenegro, Bulgaria and Lithuania

Non-Scheduled countries:

Countries other than United Kingdom, Eire, Northern Ireland, New Zealand, Japan, Sweden, Brunei, Greece, Luxembourg, Czech Republic, Malta, Slovenia, Estonia, Bahrain, Austria, Belgium, Germany, Portugal, Montenegro, Bulgaria and Lithuania
