Chok Boon Kwong, 61, bagaimanapun mengaku tidak bersalah di hadapan Hakim Rushan Lutfi Mohamed selepas kertas pertuduhan dibacakan jurubahasa dalam bahasa Mandarin.

'Chicken export to resume'

Move to take place after subsidies end starting July 1

PETALING JAYA: Several measures, including resuming the export of chicken, will be enforced once the prices of eggs and chicken are floated from July 1, says Agriculture and Food Security Minister Datuk Seri Mohamad Sabu.

"Following the termination of subsidies after June 30, the ministry will be able to assess and control the prices of goods in relation to the retail ceiling price.

"To ensure the supply of chicken and eggs is stabilised after the subsidies are terminated, the ministry will implement a soft landing mechanism," he said in a written reply to a question from Datuk Mas Ermieyati Samsudin (PN-Masjid Tanah).

Mas Ermieyati had asked the ministry whether it had conducted any studies prior to the decision to remove the poultry subsidies.

Mohamad Sabu also noted the government had decided to lift the ban on the export of chicken to enable farmers to earn an income and to enable cash flow into Malaysia.

Poultry producers will be able to export live chickens, dressed chickens and chicken parts except "day-old chicks".

The government will allow the import of chicken from recognised source countries such as Thailand, China, Brazil and Denmark.

"As for egg imports, the permitted source countries are Thailand and Ukraine," said Mohamad Sabu.

The government will continue with the Farmers' Organisation Authority's dressed chicken stockpiling programme as well as the Federal Agricultural Marketing Authority's (Fama) Madani agro sales plan to sell agricultural products at between 5%

and 10% below market prices to target groups.

"As of May 8, 2023, a total of 28,078,620 eggs have been distributed through 369 Fama outlets," he said.

The previous government had tried to scrap subsidies on July 1, last year. However, the Cabinet had decided to raise slightly the ceiling price for chicken and eggs.

Poultry producers have been under pressure over the last two years due to the increase in feed costs primarily due to supply issues following the Covid-19 pandemic as well as the Ukraine-Russian conflict.

The government allocated RM369.5mil for poultry subsidies last year.

Chickens and eggs to cost slightly more, says Fomca

PETALING JAYA: Consumers are likely to pay slightly more for chickens and eggs when their prices are left to market forces beginning July 1, according to the Federation of Malaysian Consumers Associations (Fomca).

Chief executive officer Dr Saravanan Thambirajah expects an increase of between 1% and 5% once the ceiling prices and subsidies are removed.

"It depends on the market situation, but the increase is going to be very small.

"We must understand that the government also allows imports where some players may be able to bring in cheaper items.

"If we have good competition, then the prices might be cheaper," he said.

He called on the government to collect data by doing market surveillance and anticipate the situation at least three to six months ahead.

"Based on previous data, we somehow can anticipate the livestock and food security situation.

"Don't wait until the last minute to look

for solutions, like what happened previously.

"We would be back to square one in having to providing subsidies and whatnot."

To keep prices affordable, Dr Saravanan advised consumers to refrain from panic buying, which will lead to overstocking and wastage.

"If there's more demand for local eggs or chickens, consumers should raise the issue with the agriculture and food security ministry or Fomca, so that the producers can increase production.

"That's why the floating mechanism is in place, and it allows for the best producers to make an income."

Without being overly dependent on subsidies, he said there are government measures and aids in place for B40 consumers.

"We will see what the demands are like for the M40 and T20 groups in the next few months, in order to anticipate the future market. It is too early now, as July is still some time away," he said.

Welcoming the price-float mechanism,

livestock farmers are expecting the official document from the government for their next course of action.

"We will wait for the official memo from the government to the federation about the implementation, which will contain more details for the farmers.

"We will be able to say more after that," said Tan Chee Hee, who is the president of the Federation of Livestock Farmers Association of Malaysia (FLFAM).

The federation has been pushing for the floating of the prices of eggs and chickens, due to financial constraints following the sharp price increase in chicken feed and other operating costs.

"The price control mechanism was introduced due to the inflation and bouts of global economic challenges in the past few years. The government has considered the people's livelihood burden to ensure that they can afford these essential food items."

"So they will come up with some soft-landing measures, and we look forward to more details."

While it is the best way forward to let the market decide demand and supply, Tan said what the federation and government wanted was to ensure sufficient supplies.

"After the pandemic that caused many shortages in the supply chain, there was bird flu.

"Although Malaysia is not affected by bird flu, it somehow affected our supply. That's why we will always monitor the situation to ensure food security here. We will always cooperate with the government on pricing mechanisms in the future to ensure sufficient supplies in the market," he added.

When contacted, FLFAM life honorary president Kwei Yew Tong said chicken farmers have been able to claim their subsidy for chicken eggs.

"Some have received their payment, and some are waiting," he said.

The government announced on Feb 27 that the subsidy for chicken eggs would continue until June involving a total cost of RM1.28bil, ahead of the expected floating of chicken and egg prices.

Poultry farmers not jumping for joy just yet

JOHOR BARU: The removal of price controls for chickens and eggs will give poultry farmers some "breathing space" but they are wary about being "too happy too soon," according to the Federation of Livestock Farmers' Association of Malaysia.

The federation's broiler unit chairman Kwei Yew Tong said chicken farmers have been facing challenges and operating at a loss for many years as they have had to meet government's ceiling price.

"We have to factor in the feed costs as well as logistics and with the weather being so unpredictable, it is tough.

"However, we do not want to get ahead of ourselves by being too happy too soon as the price will depend on consumers. Once the price controls are scrapped from July 1, the pricing will be determined by supply and demand.

"It is still too early to tell at this point," he said when contacted.

Agriculture and Food Security Minister Datuk Seri Mohamad Sabu said yesterday the price of eggs and chickens would be floated and subsidies for poultry producers would also end on June 30.

To ensure that the supply of chickens and eggs can be stabilised, the ministry will implement a soft landing mechanism, he told Parliament in a written reply.

'Ensure egg prices set according to their grades'

EGG traders have been urged to be ethical and refrain from selling regular eggs at the price of omega eggs.

Johor investment, trade and consumer affairs committee chairman Lee Ting Han said traders should set the price of eggs according to its grade to prevent confusing their customers.

"Without a label, it is difficult for the customers to differentiate between regular and omega eggs based on appearance alone.

"Similar to regular eggs, omega eggs have grades A, B and C but the price is unregulated by the government.

"Only regular eggs are subject to the government's price scheme, so the cost is set according to its grade," Lee said after launching the Rahmah sales package at Pasaraya Maslee in B5 Johor Street Market here.

He said the eggs could only be told apart after cracking them as omega eggs usually had a yellow lower yolk.

He noted that the Domestic Trade and Consumer Affairs

Ministry (KPDNHEP) in Johor has not received complaints about traders selling regular eggs as omega eggs but advised them to safeguard consumer rights.

He also said the supply of items such as eggs, sugar and cooking oil in Johor were sufficient.

Checks by *StarMetro* showed that a tray of 30 regular grade A eggs are sold at RM13.50 while the same number of omega eggs could cost up to RM19 per tray.

On May 15, Domestic Trade and Cost of Living Minister Datuk Seri Salahuddin Ayub encouraged consumers to file a complaint with his ministry if they purchased regular eggs that were sold as omega eggs.

"If the customer is not confident about the eggs that were purchased, they can come to us.

"My ministry will then submit the report to the Veterinary Services Department and Health Ministry to verify the standard

of the eggs," he said.

Meanwhile, on the Rahmah package programme, Lee commended Pasaraya Maslee for taking the initiative to offer discounts of 10% to 30% on 50 items such as fresh produce and basic food necessities at 18 of its outlets.

The promotion, which includes Rahmah packages filled with items like cooking oil, flour, sugar and baby products priced at RM10 to RM60, runs from May 19 until June 19, he added.

KOTA MARUDU: Seorang kanak-kanak lelaki berusia empat tahun cedera selepas diserang sekumpulan anjing liar dalam kejadian di kawasan lapang Jalan Mampakad Laut, di Pitas pada Rabu.

Dalam kejadian kira-kira jam 6 pagi itu, Muhamad Dhan Rezdey Ruddy, mengalami kecederaan di bahagian anggota badan akibat digigit haiwan berkenaan sebelum diselamatkan oleh sepasang suami isteri yang berada di lokasi.

Ketua Polis Daerah Kota Marudu, Superintenden Zairolnizal Ishak berkata, pihaknya menerima laporan kejadian itu daripada seorang pengadu berkaitan mangsa yang diserang sekumpulan anjing liar dan telah dirujuk ke Hospital Pitas.

Katanya, hasil siasatan mendapati pengadu bersama suami kebetulan lalu di lokasi kejadian dengan menaiki motosikal menuju ke Dataran Bengkoka.

"Pengadu telah melihat sekitar tujuh ekor anjing sedang menyalak serta berkerumun dan menggigit sesuatu. "Pengadu kemudian menghampiri sebelum terlihat seorang kanak-kanak lelaki dalam keadaan tertiarap tanpa pakaian serta berlumuran darah sedang digigit kumpulan anjing tersebut. Pengadu kemudian memanggil suaminya untuk menghalau kumpulan haiwan itu dan segera menyelamatkan mangsa," katanya dalam kenyataan pada Khamis. Zairolnizal berkata, anjing yang menyerang kanak-kanak itu adalah anjing liar yang sering berkeliaran di kawasan tersebut dan Dataran Bengkoka. "Ketika kejadian, ibu mangsa keluar untuk bekerja di kawasan berhampiran dengan berjalan kaki dan mangsa menyusul dari belakang tanpa pengetahuan ibunya serta neneknya. "Ibu mangsa meninggalkan anaknya di rumah di bawah jagaan nenek dan jarak perjalanan rumah mangsa ke tempat kerja kira-kira 300 meter manakala jarak lokasi kejadian dari rumah iaitu 100 meter. "Tempat kejadian adalah di kawasan lapang berhampiran kawasan pembuangan sampah dan timbang buah kelapa sawit, namun kejadian ini kali pertama berlaku," katanya. Katanya lagi, pemeriksaan mendapati terdapat banyak kesan gigitan dan cakaran oleh haiwan berkenaan di seluruh anggota badan mangsa. "Bagaimanapun, mangsa kini berada dalam keadaan stabil tetapi masih dalam rawatan lanjut selain dirujuk ke Hospital Wanita dan Kanak-Kanak Sabah di Likas.

"Kejadian ini juga telah dimaklumkan kepada Pegawai Daerah Pitas dan Majlis Daerah Pitas untuk tindakan selanjutnya," katanya. - *Sinar Harian*

PETALING JAYA: The prices of chicken and eggs will be floated from July 1, said Minister of Agriculture and Food Security Datuk Seri Mohamad Sabu.

[Malay Mail](#) reported that Mohamad or Mat Sabu said the government subsidies for eggs and chickens would end after June 30, while assuring that the domestic trade and cost of living ministry would control the price of these two items.

“In order to ensure that the supply of chicken and eggs can be stabilised after the subsidy is terminated, the ministry will implement several soft landing mechanisms,” he said in the Dewan Rakyat today (June 8).

This will include abolishing the ban on the export of live broiler chickens except for day-old chicks, whole chickens, and chicken cuts completely from July 1 and allow the importation of poultry eggs from recognised source countries.

Mat Sabu said the countries permitted for the importation of chicken are Thailand, China, Brazil and Denmark. While for the importation of eggs, the countries allowed are Thailand and Ukraine.

He also said this approach would allow farmers to earn an income from the export market and help cash flow into Malaysia.

Mat Sabu also stated that the ministry will continue the stockpiling programme for whole chickens under the Board of Farmers’ Organisations.

KUALA LUMPUR, June 8 — Minister of Agriculture and Food Security Datuk Seri Mohamad Sabu confirmed that the price of eggs and chicken in the market will be floated from July 1. In a written Dewan Rakyat reply, Mohamad also known as Mat Sabu said government subsidies for eggs and chickens would end after June 30, adding that the domestic trade and cost of living ministry would control the price of these two items. “In order to ensure that the supply of chicken and eggs can be stabilised after the subsidy is terminated, the ministry will implement several soft landing mechanisms,” he said. This includes abolishing the ban on the export of live broiler chickens except for day-old chicks, whole chickens, and chicken cuts completely from July 1 and allowing the importation of poultry and eggs from recognised source countries. “For the importation of chicken, the permitted source countries include Thailand, China, Brazil and Denmark. While for the importation of eggs, the source countries allowed are Thailand and Ukraine. “This will enable farmers to earn income from the export market and help cash flow into the country,” he said. He said the ministry will continue the stockpiling programme for whole chickens under the Board of Farmers' Organisations adding that, as of May 7, 63 per cent of the target of 2,177 metric tonnes has been stored. He added that the ministry will continue the Civil Agro Sales Program by the Federal Agricultural Marketing Board (Fama) to market various agricultural products including eggs, with prices 5 to 10 per cent lower than the local bazaar, especially in low-income housing areas. “Until May 8, a total of 28,078,620 eggs have been distributed through 369 FAMA outlets,” he said. He was responding to Parti Pribumi Bersatu Malaysia’s (Bersatu) Masjid Tanah MP Datuk Mas Ermieyati Samsudin’s question on whether the government had conducted a comprehensive study on the effects of the chicken and eggs price control policy change. Currently, the controlled retail price for a standard chicken or a chicken that has been slaughtered, cleaned and with all parts retained was RM9.40 per kg in Peninsular Malaysia; RM9.90 per kg in Langkawi; between RM9.80 and RM12.90 per kg in Sarawak, depending on the district; either RM11 or RM11.30 per kg in Sabah, again based on the district; and RM11.30 per kg in Labuan.

KUALA LUMPUR: The price of eggs and chicken will be floated starting July 1, says Datuk Seri Mohamad Sabu.

The Agriculture and Food Security Minister added that the Domestic Trade and Cost of Living Ministry was in charge of determining if there would be price caps in place during festive occasions, for example. He also said that the subsidies for poultry producers would end after June 30. "To ensure that the supply of chicken and eggs can be stabilised after the subsidy is terminated, the ministry will implement a soft landing mechanism," he said in a written reply.

Datuk Mas Ermieyati Samsudin (PN-Masjid Tanah) had asked if the ministry had conducted any detailed studies prior to the decision to scrap poultry subsidies. Mohamad Sabu also said that the government would also lift the ban on chicken exports from July 1. He said this would enable farmers to earn revenue from the export market and to facilitate cash flow into the country.

He said that poultry producers would be able to export live chicken, dressed chicken and chicken parts but not day-old chicks. He added that the government would also allow chicken imports from recognised source countries including Thailand, China, Brazil and Denmark. "As for egg imports, the permitted source countries are Thailand and Ukraine," said Mohamad Sabu. Menurut jawapan di Dewan Rakyat, subsidi ayam dan telur akan berakhir pada 30 Jun dan pengapungan harga bermula pada 1 Julai. Mohamad atau dikenali Mat Sabu memaklumkan menerusi jawapan lisan menjawab pertanyaan kepada Ahli Parlimen Masjid Tanah Datuk Mas Ermieyati Samsudin (PN-Masjid Tanah) berhubung tempoh harga ayam dan telur akan diapung. Mohamad berkata, penamatan tersebut bagi membolehkan Kementerian Perdagangan Dalam Negeri dan Kos Sara Hidup (KPDN) menilai serta mengawal harga barangan sama ada naik atau turun, berbanding harga saling runcit ketika ini. Tambahnya, bagi memastikan bekalan ayam dan telur dapat distabilkan selepas subsidi ditamatkan, KPKM melaksanakan mekanisme “soft-landing” (pemulihan bertahap). Beliau berkata, antara yang dilaksanakan ialah memansuhkan sekatan eksport ayam pedaging hidup kecuali “Day Old Chick” (DOC), ayam bulat, dan keratan ayam sepenuhnya serta membenarkan pengimportan ayam dan telur dari pelbagai negara sumber yang diiktiraf. “Bagi pengimportan ayam, negara sumber yang dibenarkan termasuklah Thailand, China, Brazil, dan Denmark. Manakala bagi pengimportan telur, negara sumber yang dibenarkan ialah Thailand dan Ukraine,” katanya. Selain itu, beliau berkata, kerajaan akan meneruskan program simpanan stok ayam bulat di bawah Lembaga Pertubuhan Peladang (LPP) dan program Program Jualan Agro Madani oleh Lembaga Pemasaran Pertanian Persekutuan (Fama). “Program Jualan Agro Madani oleh Fama memasarkan pelbagai hasil pertanian termasuk telur, dengan harga 5 hingga 10% lebih rendah dari pasar basar setempat, terutamanya di kawasan kumpulan berpendapatan rendah.” Sehingga 8 Mei 2023, sebanyak 28,078,620 biji telur telah diedarkan melalui 369 outlet FAMA,” katanya
