KAEDAH-KAEDAH BINATANG (KAWALAN PENYEMBELIHAN) (PINDAAN) 2018

PADA menjalankan kuasa yang diberikan oleh seksyen 86 Akta Binatang 1953 [*Akta 647*], Menteri membuat kaedah-kaedah yang berikut:

**Nama dan permulaan kuat kuasa**

1. (1) Kaedah-kaedah ini bolehlah dinamakan **Kaedah-Kaedah Binatang (Kawalan Penyembelihan) (Pindaan) 2018**.

(2) Kaedah-Kaedah ini mula berkuat kuasa pada 1 Disember 2018.

**Pindaan kaedah 17**

2. Kaedah-Kaedah Binatang (Kawalan Penyembelihan) 2009 [*P.U. (A) 213/2009*] dipinda dalam kaedah 17—

(a) dengan menggantikan perkataan “seratus ringgit” dengan perkataan “sepuluh ribu ringgit”; dan

(b) dengan menggantikan perkataan “dua puluh ringgit” dengan perkataan “lima ratus ringgit”.

ANIMALS ACT 1953

ANIMALS (CONTROL OF SLAUGHTER) (AMENDMENT) RULES 2018

IN exercise of the powers conferred by section 86 of the Animals Act 1953 [*Act 647*], the Minister makes the following rules:

**Citation and commencement**

1. (1) These rules may be cited as the **Animals (Control of Slaughter) (Amendment) Rules 2018**.

(2) These Rules come into operation on 1 December 2018.

**Amendment of rule 17**

2. The Animals (Control of Slaughter) Rules 2009 [*P.U. (A) 213/2009*] are amended in rule 17—

(a) by substituting for the words “one hundred ringgit” the words “ten thousand ringgit”; and

(b) by substituting for the words “twenty ringgit” the words “five hundred ringgit”.
