ANIMALS ORDINANCE 1953

ANIMALS (AMENDMENT) RULES 1991

In exercise of the powers conferred by section 86 of the Animals Ordinance 1953, the Minister makes the following rules:

1. These Rules may be cited as the **Animals (Amendment) Rules 1991**.

2. Rule 3 of the Animals Rules 1962 is amended—

- (a) by deleting the word "or" after the semicolon in paragraph (b) or subrule (1);
- (b) by substituting for the full stop in paragraph (c) of subrule (1) a semicolon;
- (c) by inserting, immediately after paragraph (c) of subrule (1), the following new paragraphs (d), (e), (f) and (g):
- “(d) The Railway Station at Rantau Panjang;
- (e) The Customs Station at Rantau Panjang;
- (f) The Animal Quarantine Station at Rantau Panjang;
- or
- (g) The Customs Station at Bukit Kayu Hitam.”;
- (d) by inserting immediately after paragraph (b) of subrule (2), the following new paragraphs (c), (d) and (e):
- “(c) The Port of Pasir Gudang;
- (d) The Port of Kuantan;
- (e) The Customs Station at Pengkalan Kubur.”;
- (e) by substituting for the full stop in paragraph (b) of subrule (2) a semicolon; and
- (f) by inserting, immediately after the words "Kuala Lumpur" in subrule (3), the words "or Johor Bahru".
