ANIMALS ORDINANCE 1953

ANIMALS (IMPORTATION) (AMENDMENT) ORDER 1990

In exercise of the powers conferred by subsection (1) of section 5 of the Animals Ordinance 1953, the Minister makes the following order:

Citation.

1. This Order may be cited as the **Animals (Importation) (Amendment) Order 1990**.

2. Paragraph 3 (3) of the Animals (Importation) Order 1962 is amended—

(a) by inserting immediately after item (v) the following new items:

- “(vi) The Penang International Airport, Bayan Lepas;
- (vii) The Sultan Ismail Airport, Johor Bahru;
- (viii) The Customs Station at Rantau Panjang;
- (ix) The Railway Station at Rantau Panjang;
- (x) The Animal Quarantine Station at Rantau Panjang;
- (xi) The Port of Kuantan;
- (xii) The Port of Pasir Gudang;
- (xiii) The Customs Station at Bukit Kayu Hitam; or
- (xiv) The Customs Station at Pengkalan Kubur.”;

(b) by deleting the word “or” at the end of subparagraph (iv); and

(c) by substituting for the full stop in subparagraph (v) a semicolon.
