In exercise of the powers conferred by section 39 (2) of the Veterinary Surgeons Act, 1974, the Council with the approval of the Minister hereby makes the following regulations:

**Citation,
commencement
and applica-
tion.**

1. (1) These Regulations may be cited as the **Veterinary Surgeons (Forms and Fees) Regulations, 1975**, and shall be deemed to have come into force on the 1st day of June, 1975.

(2) These Regulations shall apply throughout Malaysia.

2. (1) A veterinary surgeon who is entitled to be registered may apply for registration under the Act by submitting the duly filled form appearing as in Form A in the Schedule and paying a fee of \$50.

(2) A veterinary surgeon whose name has been registered either in Part I or Part II of the Register of Veterinary Surgeons, Malaysia or both shall accordingly be issued a certificate or certificates as in Form B or C of the Schedule or both.

3. (1) Any registered veterinary surgeon may apply for an annual practising certificate by submitting to the Registrar a duly filled Form D as in the Schedule and paying a fee of \$25 and, if the application is made after 1st December, an additional fee of \$25:

then Statutory Bodies* *(PU(A)228/78)* Provided that an employee of the Government shall be exempted from the payment of such fees.

(2) The practising certificate shall be as in Form E in the Schedule.

4. (1) A veterinary surgeon registered anywhere outside Malaysia and whether or not qualified to be registered under the Act may apply for a permit to practise as a veterinary surgeon by submitting the duly filled form as appearing in Form F in the Schedule and paying a fee of \$25.

(2) The temporary permit to practise shall be as in Form G in the Schedule.
