### FEES ACT 1951

#### FEES (FACILITIES) (KLUANG VETERINARY INSTITUTE) ORDER 1995

In exercise of the powers conferred by sections 3 and 10 of the Fees Act 1951, the Yang di-Pertuan Agong makes the following order: Act 209.

1. This order may be cited as the **Fees (Facilities) (Kluang Veterinary Institute) Order 1995** and shall come into force on 17 August 1995. Citation and commencement.

2. In this Order, unless the context otherwise requires— Interpretation.

“day” means from 8.00 a.m. to 4.15 p.m. for Monday to Friday and from 8.00 a.m. to 12.45 p.m. for Saturday;

“half day” means from 8.00 a.m. to 12.45 p.m.;

“Institute” means the Kluang Veterinary Institute.

3. (1) The fees and payments prescribed in column (2) of the First Schedule shall be charged by the Institute in respect of the facilities specified in column (1) of the said Schedule. Fees and payments.

(2) Where the use of the facilities exceeds one day, the hirer of the vehicle or video recording is required to pay the overtime allowance, food allowance, daily allowance and accomodation allowance, as the case may be, to the driver, attendance and video recording officer at the rate prescribed in the Second Schedule in addition to the fees and payments prescribed in subparagraph (1).

Payment of fees  
and payments.

4. (1) The fees and payments prescribed under this Order shall be payable to the Institute by persons to whom the facilities are made available.

(2) All fees and payments prescribed under this Order shall be payable in full.

Remission.

5. The Director of the Institute may, in his discretion in any particular case remit either wholly or in part any fee or payment specified in the Schedules.
