emilik haiwan ternakan yang membiarkan lembu mereka berkeliaran bebas di kawasan perumahan dan jalan raya boleh dikenakan tindakan undang-undang di bawah Enakmen Mengawal Lembu-Kerbau 1971 termasuk kompaun dan tindakan penguatkuasaan lain.

Pengarah Jabatan Komunikasi Korporat Majlis Bandaraya Diraja Klang (MBDK), Norfiza Mahfiz berkata, pihaknya tidak akan berkompromi dalam isu keselamatan awam yang berpunca daripada haiwan ternakan berkeliaran.

"Tindakan boleh diambil terhadap pemilik ternakan yang membiarkan haiwan mereka berkeliaran di bawah Enakmen Mengawal Lembu, Kerhau 1972

Lembu-Kerbau 1971.

"Antara tindakan termasuklah pengeluaran kompaun kepada pemilik," katanya

Beliau berkata, walaupun tiada aktiviti penangkapan

lembu rayau dilakukan setakat ini, fokus MBDK tertumpu kepada tindakan penguatkuasaan berterusan dan pemantauan rutin di kawasan yang sering menerima aduan.

Menurutnya, berdasar-

kan rekod MBDK, sebanyak 67 aduan diterima pada 2023, meningkat kepada 88 aduan pada 2024 manakala 35 aduan direkodkan sehingga September tahun ini.

"Bandar Botanik dan Ka-

par antara kawasan yang mencatatkan aduan tertinggi," katanya.

Norfiza berkata, dalam memastikan keselamatan pengguna jalan raya tidak terjejas, MBDK melaksanakan Operasi Tindakan Penguatkuasaan Lembu Berkeliaran sebanyak 12 kali setahun, dengan kerjasama Jabatan Penguat kuasa dan Jabatan Pelesenan MBDK.

Katanya, tiada kawasan khas ternakan disediakan setakat ini dan pemilik haiwan perlu mendapatkan permit penternakan daripada Jabatan Perkhidmatan Veterinar (JPV) sebelum menjalankan aktiviti berkenaan.

Beliau turut menegaskan pemantauan berkala akan diteruskan bagi menangani aduan penduduk dan mengelakkan kejadian tidak diingini termasuk kemalangan jalan raya akibat lembu berkeliaran.

Harian Metro semalam melaporkan masalah lembu dan kerbau rayau ber dekatan kawasan perumahan di sekitar Klang sejak sekian lama menimbulkan keresahan penduduk.

Selain menjejaskan kebersihan yang mana najis haiwan ternakan itu bersepah di atas jalan raya, ia turut mengundang risiko kemalangan terutama pada waktu malam terutamanya di kawasan tidak berlampu.

Penduduk mendakwa haiwan ternakan itu dibiarkan berkeliaran tanpa ikatan dan tanpa pengawasan pemilik. Malah, ada antara haiwan itu didapati merayau di tanah milik kerajaan tanpa sebarang keizinan.

### RESAH ANCAMAN ANJING LIAR, PENDUDUK TUNTUT TINDAKAN SEGERA

Jerantut: Peningkatan jumlah anjing liar yang berkeliaran di perumahan kawasan sekitar bandar ini meresahkan penduduk apabila haiwan itu sahaja mengancam bukan keselamatan, malah mencemari persekitaran kebersihan termasuk di kawasan masjid.

Difahamkan, lebih 50 anjing liar dilaporkan berkeliaran hampir setiap hari di beberapa lokasi tumpuan, antaranya Taman Inderapura, Taman Saujana Utama, Taman Saujana Perdana serta kawasan industri Jerantut.

Lebih membimbangkan, beberapa anjing ini turut dilihat berhampiran Masjid Tengku Mahkota Abdullah dan ada yang memasuki kawasan masjid, sekali qus menimbulkan rasa tidak selesa dalam kalangan jemaah.

Penduduk, Rosmani Sulaiman, 61. berkata keadaan itu meruncing selepas semakin insiden berlaku anjing kanak-kanak mengejar Taman Saujana Utama barubaru ini. "Kami benar-benar risau keselamatan anak-anak dan penduduk. "Diharapkan Mailis Daerah Jerantut (MDJ) dan Jabatan Veterinar segera menjalankan operasi tangkapan anjing liar bagi memastikan keselamatan penduduk serta kebersihan kawasan perumahan," katanya ketika ditemui. hari ini.

Seorang lagi penduduk, Mohd Kamaruddin Napiah, 58, dari Taman Inderapura berkata, kehadiran anjing liar bukan sahaja menakutkan penduduk, malah menimbulkan masalah kebersihan apabila haiwan itu menyelongkar tong sampah.

"Ada yang menumbangkan tong sampah dan mengoyakkan plastik hingga menyebabkan sisa bertaburan di jalan. Keadaan itu menarik haiwan lain seperti tikus dan biawak datang ke kawasan rumah.

"Masalah ini tidak boleh dibiarkan berlarutan. Kami mahu tindakan tegas dan berterusan, bukan sekadar operasi sementara," katanya.

Sementara itu, jurucakap MDJ memaklumkan pihaknya sudah memasang beberapa perangkap di lokasi tumpuan, terutama di kawasan industri Jerantut.

"Anggota penguat kuasa MDJ sudah memasang perangkap di kawasan dikenal pasti. Operasi akan diteruskan, terutama pada waktu malam apabila anjing liar lebih aktif," katanya.

# CAGED, SICK, VOCAL CORDS REMOVED — M'SIAN SHOCKED TO FIND BACKYARD PUPPY BREEDING MILL





A Malaysian animal rescuer left shocked after was uncovering what is alleged to be an illegal puppy breeding mill run by an elderly couple Shan, the founder of Woof My Roof, an initiative dedicated to improving the lives of stray dogs, said it was her first time witnessing a breeding mill firsthand.

On Sunday, 26 October, pretending to be a buyer, Shan managed to convince the couple to show her more puppies – only to be met with a heartbreaking scene.

"Today, we witnessed a breeding mill with 60 to 70 dogs... Trapped in filthy small cages with bowls of water filled with algae," she wrote on an Instagram post. Inside the home, she reportedly found Poodles, Pomeranians, Beagles, Jack Russells, and Shih Tzus, all kept in cramped cages and repeatedly bred for profit.

"Locked in cages their whole life, used and used again to breed, because someone out there wants a cute, 'branded' dog," she said.





According to Shan, many of the dogs were sick and had been "debarked" – a surgery that involves removing a dog's vocal cords to stop them from barking

She claimed the couple told her that "a guy comes to the house to do the surgery". "No names, no love, no voices," she wrote. Following the discovery,

Shan appealed to the public to help raise funds to "bail out" the dogs and provide them with medical care "Please help us set them free. We need funds to 'bail' them out. We need funds for medical attention - they will all be sent to the vet to get checked, spayed or neutered. vaccinated. and nursed back to aood health," she said.

She estimated that she would need about RM100,000 in total, or about RM2,000 per dog.

She explained that her goal is to negotiate with the couple to surrender all the dogs SO thev can be rehomed in safe, loving environments. While many social media users praised Shan's compassion efforts to help the animals, others urged her to report the alleged breeders to the "Thanks authorities advocating against buying animals. But why bail them? Isn't this illegal an operation? You can make a police report and rescue all."

"If this is a backyard breeding operation, work with animal control – they can seize the animals while your team provides aftercareThey also warned that paying money to the breeders could set a dangerous precedent, rewarding illegal operations and potentially fuelling further cruelty.

"Paying money to the breeder NOT the solution. breeder could very well take the money and start another mill." one puppy user cautionedSAYS has reached out to Shan for clarification on whether she has filed a police report and for comment on the case.
